
Properties can be let if they have an energy rating from A to E.

## **Energy rating and score**

Properties get a rating from A (best) to G (worst) and a score. The better the rating and score, the lower your energy bills are likely to be.

#### Primary energy use

# How this affects your energy bills

An average household would need to spend £1,763 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.
