
Properties can be let if they have an energy rating from A to E.

# How this affects your energy bills

An average household would need to spend £1,311 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

8. Solar water heating	£4,000 - £6,000	£37
9. Replace single glazed windows with low-E double glazed windows	£3,300 - £6,500	£43
10. Solar photovoltaic panels	£5,000 - £8,000	£292
