

How this affects your energy bills

An average household would need to spend £1,118 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

Step 2: High heat retention storage heaters

Typical installation cost	£800 - £1,200
Typical yearly saving	£248
Potential rating after completing steps 1 and 2	84 B

Step 3: Replacement glazing units

Typical installation cost	£1,000 - £1,400
Typical yearly saving	£53
Potential rating after completing steps 1 to 3	85 B
